TITLE: Registered Nurse for the Community Alternatives Program (CAP/DA)
(Contract position – up to 29 hours per week)

LOCATION: Department of Social Services, Danbury, NC

SALARY RANGE: \$30.00 - \$40.00/hour (depending upon qualifications)

CLOSING DATE: Open until Filled (N.C. State Application PD-107 must be submitted by 5:00 pm)

GENERAL DESCRIPTION: The Community Alternatives Program is a Medicaid funded service which allows individuals to receive services in their home to avoid long-term care placement. The primary purpose is to provide nursing assessments for the Stokes County Department of Social Services to individuals receiving this service. This individual will provide general health services and education to clients served.

KNOWLEDGE, SKILLS, AND ABILITIES: The nurse will have knowledge and understanding of the physical, mental, and emotional aspects of aging, the resultant diseases and infirmities and related medications and rehabilitative measures; conduct physical assessments of clients; assess and educate clients about basic care, skills, and abilities; connect families with community resources; establish and review health policies and procedures; coordinate with community based health care providers; input assessment information into the CAP computer program; and other duties as assigned. The nurse will consult with CAP/DA social workers with the Department. Considerable knowledge and skills in applying nursing practices, principles, and techniques; a working knowledge of current social and economic problems related to public health; knowledge of resources and organizations; ability to secure cooperation of clients; deal tactfully with others; use good judgement in assessing situations and making decisions.

EXPERIENCE AND TRAINING: License or certification required by statute or regulation: Licensed to practice as a Registered Nurse in North Carolina by the NC Board of Nursing. Copy of this certification will be required. Prefer someone with public health nursing experience but not required. CPR & First Aide certification required annually.

APPLICATION PROCESS: All applicants must complete a State Application Form (PD-107). Applications are available from the Department of Social Services and on the Stokes County Website.
